Using careful planning and prudent fiscal management, Pinewoods Camp is able to cover the costs of summer operations through our camper fees, including year-round staffing costs and ongoing maintenance and repairs. Protecting our facilities and fragile grounds and preserving the camp's unique character, however, requires an additional level of sustained financial support.

Your Planned Gift will, in part, enable Pinewoods Camp to make needed improvements and upgrades, including the replacement of seriously dilapidated buildings when necessary.

It will also provide Pinewoods with the "self-insurance" needed to survive, and recover from, catastrophic events. Our insurance broker classifies camp as a seasonal property. As such, our risk insurance covers only 80% of the depreciated, appraised cash value of the larger buildings, not the total replacement cost. The cost of insuring the other 80-odd cabins, bathhouses, and smaller buildings would be greater than the cost of re-building them ourselves.



As you plan your financial legacy, we encourage you to make Pinewoods Camp one of your beneficiaries. Bequests from you, and like-minded others, will enable Pinewoods to maintain a carefully managed fund which will ensure both its *preservation* and *protection*, continuing the Pinewoods experience for generations to come.

You should consult your attorney about the preferred wording, but typical wording is, "I hereby give, devise, and bequeath ______(a dollar amount, or all or a percentage of the rest, residue or remainder of my estate) to Pinewoods Camp, Inc., a nonprofit corporation located at 80 Cornish Field Road, Plymouth, in the state of Massachusetts, for its general purposes."
